To: Prospective Bidders

From: Procurement Operations Department, Houston Community College

Subject: Questions and Answers Responses

1. The spec calls for routing cracks from 1/4" to make them 1/2". This would increase the probability for future water intrusion; his is not typical for asphalt. Can the typical spec be used, omitting the routing of the cracks?

Response: Rout out cracks per the sealant manufacture of the sealant specification for width to depth ratio.

2. What color striping is required at each lot?

Response: Safety Yellow.

3. **Central Campus:** In Lots "A" and "C" there are many cracks with good sealant. Are we to reseal those cracks, or leave them as existing? Does Lot "C" need a gate? What would the specs for a gate be?

Response: No, good sealant shall remain and should not be resealed. A gate is not part of the scope of work.

4 North Forest Campus: Is the entire lot to be reconstructed, or only deteriorated areas? Is the current construction going to change any of the existing parking? How is the tie in of the new construction going to join existing lot? How many phases need will the work need to be done in?

Response: North Forest shall be removed from this IFB. (See Amendment No. 2)

5 **Katy Campus:** The stop signs are very faded; do we include replacing signage? Do we include painting wheel stops? Do the light pole bases need to be painted? How many phases will work in Lot "A" need to be done in?

Response: Signage shall not be included. Wheel stops and light pole bases are included. Lot shall be completed in one phase.

6 Alief Campus: There is no Lot "B"?

Response: Lot "B" has been Removed. (See Amendment No. 2)
